## Old Business

Minutes from the April 13<sup>th</sup>, 2019 meeting were presented. Motion to approve the amended minutes by John; second by Rondell. Motion approved unanimously.

The January-December financial report was provided by Sammy. Sammy also agreed to provide more detailed financials if anyone wants to look at them further. Motion to approve these by Alex; second by Rondell. Motion approved unanimously.

Signs – Sammy got some signs made and placed them by the cattle guard and on the cemetery fence.

We did have a work day last year and repaired several graves.

Sammy and Rondell recently replaced the flag

Ground Penetrating Radar – based on last year's approval, Sammy pursued getting Global GPR Services out of Canada to come down and survey the cemetery. It took about two days and ran the device through the cemetery in 18-inch increments. He found 213 burials (based on the ground disturbance). We have about 390 names from headstones. Sammy has purchased the Crypt Keeper software and is using it to plot information about our plots. Sammy gave a demonstration of how to use the links provided off the [www.dunklecemetery.com](http://www.dunklecemetery.com) website. We appreciate Sammy and Rondell's efforts on this.

## New Business

As of year-end 2019, current finances are split as follows:

Checking	\$63,546.16
Preservation Fund	\$61,860.72

Mowing for this year remains unchanged at \$130 per occurrence.

Decoration Day this year will be May 17<sup>th</sup>. Decoration Day is always the 3<sup>rd</sup> Sunday of May. Everyone else is welcome at any time.
